A competition is open for the attribution of 1 Research Grant in the framework of the INNOVMAR NORTE-01-0145-FEDER-000035, with reference INSEAFOOD, within the R&D Institution CIIMAR (Interdisciplinary Centre of Marine and Environmental Research), supported by North Portugal Regional Operational Programme (NORTE2020), according to the following conditions:

1. Scientific area: Biological Sciences

2. Admission requirements

We seek a candidate holding a Bachelor Degree in Biological Sciences, Aquaculture or similar.

The candidate must have good skills in follow-up experiments with aquatic animals, including maintenance of the rearing systems and of animals.

We will valorise holding a FELASA category B certification and experience in: growth and digestibility trials with fish; formulation and manufacture of experimental diets; proximate analysis; blood sampling and blood biochemistry analysis; measurement of intermediary and digestive enzymes activity; data processing and statistical analysis.

In addition, a demonstrated capacity to perform independent research and to develop new methodologies and techniques will be key aspects for selection of a suitable candidate

3. Work plan:

The candidate will participate in all tasks of the project, namely:

Diet formulation and production;

Follow-up of trials, including maintenance of the rearing systems and of the animals; Sampling of animals, blood and tissues for analysis;

Proximate analysis of ingredients, diets, feces and biological material;

Biochemical analysis of blood and plasma metabolites;

Determination of selected enzyme activity in target tissues;

Histological processing and analysis of target tissues;

Expression of genes involved in metabolism;

4. Legislation and official rules:

Law nº. 40/2004, 18th August (Research Fellowship and Studentship Regulation); Regulations for Studentships and Fellowships of the Fundação para a Ciência e a Tecnologia, I.P. — 2015 and CIIMAR Grants Regulation.

5. Work place:

The work will be carried out at CIIMAR, Marine Zoology Station and NUTRIMU lab, under the scientific supervision of Prof. Aires Oliva Teles and Dr. Helena Peres

6. Duration of the grant:

Duration of six (6) months, starting September 2017, under the regime of exclusive dedication, eventually renewable according to legal terms, up to 15 months.

7. Monthly maintenance stipend:

The monthly maintenance allowance is \in 745 (seven hundred and forty-five Euros Taxe Free), in agreement with the monthly maintenance stipend table of the grants directly attributed by FCT, I.P. within the country (<u>http://alfa.fct.mctes.pt/apoios/bolsas/valores</u>).

8. Selection methods:

The ranking of candidates will be performed by a global evaluation based on:

- Evaluation of the Curriculum Vitae -30%;
- Experience in the research field 30%;
- Interview 40% (Only the short listed candidates will be interviewed).
