ANNOUNCEMENT FOR THE OPENING OF ONE RESEARCH GRANT (BI) VACANCY

Reference: 2025_093_BI_MiMo

A competition is open for the attribution of one (1) research grant in the framework of the project "MiMo- *Chlorella vulgaris* aquafeed supplementation as microbiota-gut brain modulator in *Dicentrarchus labrax*", reference COMPETE2030-FEDER-00764400 (n.º 16473), funded by the European Regional Development Fund (FEDER) through the Competitiveness and Internationalization Operational Program (COMPETE 2030), at the Research Unit - Interdisciplinary Centre of Marine and Environmental Research, according to the following conditions:

- 1. Scientific Area: Biological Sciences.
- **2. General admission requirements:** Any national, foreign and stateless candidate(s) who hold a Bachelor's degree or integrated Master's degree in animal science, aquaculture, biological sciences or related scientific areas; and a scientific and professional curriculum whose profile is suited for the activity to be performed focus on aquaculture.

The research grants (BI) are intended for carrying out R&D activities by students enrolled in an integrated master's degree or a master's degree or in a course that do not confer an academic degree* aiming to consolidate their scientific training through the development of research work leading to obtaining the respective academic degree, integrated into R&D projects: if the applicant is not yet enrolled; it must meet the requirements to register; enrolment will be mandatory and proof necessary at the moment of scholarship contracting.

- * In the case of enrolment in courses that do not confer academic degree, the research grant can only be awarded to those who do not exceed, with the signing of the research grant contract in question, including possible renewals, an accumulated period of two years in this type of grant, consecutive or interpolated.
- **3. Specific admission requirements:** The specific admission requirements for the competition are as described below. Candidates must have previous skills and experience in:
 - a) Demonstrated technical and scientific skills and/or experience in molecular biology, microbiology, and bioinformatics;
 - b) Experience in fish rearing and challenge trials;
 - c) Capacity to analyse health related traits in aquatic animals, such as immune and oxidative stress parameters;
 - d) Advanced knowledge of Excel and data analysis;
 - e) Be fluent in Portuguese and English, both written and spoken.

The jury reserves the right to close the application in case none of the candidates meets the desired profile.

4. Working plan: The candidate will participate in the day-to-day routines of the project MiMo, including analysis of samples and data management and interpretation. The candidate will be also responsible for progress reports writing and participation in progress meetings.

The candidate will mainly be involved in the following activities: i) sampling of tissues for analysis; ii) performing data analysis; (iii) participation in dissemination activities; and (iv) participation in management activities.

- **5. Legislation and official rules:** Law nº.40/2004, 18th August (Research Fellowship Holder Statute) in its current version; Regulations for Studentships and Fellowships of the Fundação para a Ciência e a Tecnologia, I.P. and CIIMAR Grants Regulation.
- **6. Workplace:** The work will be carried out in the Aquatic Animal Health research team located at CIIMAR Interdisciplinary Centre of Marine and Environmental Research, Novo Terminal de Cruzeiros do Porto de Leixões, Av. General Norton de Matos s/n, 4450-208 Matosinhos, Portugal, under the supervision of Dr. Márcia Saraiva.
- **7. Duration of the contract:** Duration of 12 months, starting in December 2025, under the regime of exclusive dedication.
- **8. Monthly salary:** The monthly maintenance allowance is 1040,98 €, in agreement with the monthly maintenance stipend table of the grants directly attributed by FCT, I.P. within the country, by bank transfer payment.
- **9. Selection methods:** The ranking of candidates will be performed by an initial evaluation based on: Evaluation of the Curriculum Vitae (EC) -90%;

The Evaluation of the Curriculum Vitae will be performed according to the following criteria:

- I. Average of the classification obtained in Graduation degree (M) 40%;
- II. Demonstrated experience in the requested areas (ERA)- 40%;
- III. Motivation letter (ML) 10%.

The Evaluation of the Curriculum Vitae will be performed according to the following criteria: EC = [40%M+40%ERA+10%ML]

The evaluation process may include an interview (INT), for the first 3 positions, with the only purpose of clarifying aspects related to the research experience, with a relative weight of 20% for the total score. Candidates may be interviewed by video conference or in person.

Being the Final classification (CF) performed according to the following criteria:

CF = 80%EC+20%INT

The candidate with the highest score will be offered the position. The jury reserves the right to not assign the position depending on the quality of the applications.

11. Deadline for application and presentation of applications: The application period starts 31/10 until 13/11/2025. Applications must be formalised by e-mail to rh@ciimar.up.pt and must explicitly state the announcement reference on the subject: **2025_093_BI_MiMo**.

Applications shall include all supported documents encompassed by section 2 and 3 for tender admission, namely:

- a) Copy of the eligibility certificates;
- b) Curriculum vitae, detailed and structured pursuant to sections 2 and 3; including information regarding: scientific and technological production, applied research activities, extension activities and knowledge dissemination and science, technology and innovation programs;
- c) Other documentation relevant for the evaluation of qualifications in a related scientific area;
- d) Motivation letter;
- e) Contact e-mail address and phone number;
- f) The reference of this application (indicated in this announcement).

All candidates who formalise their applications in an improper way or fail to prove the requirements imposed by this tender are excluded from admission. In case of doubt, the panel is entitled to request any candidate to present further documentation supporting their statements. False statements provided by the candidates shall be punished by law.

- 12. Form of advertising/notification of results: Both admitted and excluded candidate list and final classification list will be notified by e-mail.
- 13. Preliminary Hearing and Final Decision Deadline: Pursuant to article 121 of the Administrative Procedure Code, after publication, all candidates have 10 working days to respond. Panel's final decisions are pronounced within a maximum period of 90 days, counting from deadline for submission of applications.

Tender is exclusively destined to fill this specify vacancy and can be terminated at any time until approval of final candidate list, expiring with the respective occupation of said vacancy.

14.
