

Announcement for the opening of one research grant (bi) vacancy

Reference: 2025_113_BI_Charcos

A call for applications is open for 1 Research Grant for a Master's student enrolled in non-degree course, within the framework of the BioAqua Matosinhos project, supported by Fundação Belmiro de Azevedo, according to the following conditions:

1. **Scientific Area:** Biological Sciences

2. Admission requirements:

The candidate must be enrolled in an extension course integrated into the pedagogical project of a higher education institution, developed in association or cooperation with one or more R&D units. If the candidate is not yet enrolled, they must meet the enrollment requirements; enrollment will be mandatory and proof will be required at the time of signing the scholarship contract.

This grants for students who are enrolled in non-degree-granting courses may only be awarded to those who do not exceed, with the signing of the grant contract in question, including possible renewals, an accumulated period of two years in that type of grant, whether consecutive or intermittent.

The candidate must cumulatively meet the following requirements:

- Master's degree in Biology, Biological Sciences, Environmental Sciences or related fields;
- Solid knowledge of biodiversity and ecology of small water bodies;
- Proven experience in conducting fieldwork for inventory and/or restoration of water bodies;
- Experience in managing social media (namely Instagram, Facebook, YouTube);
- Experience in scientific dissemination to diverse audiences;
- Proficiency in oral and written communication in Portuguese and English;
- Driver's license;
- Immediate availability.

Preference will be given to candidates with proven professional experience and/or a master's degree in the thematic area of the vacancy, especially in the development of fieldwork for inventory and/or restoration of water bodies, as well as high motivation, autonomy, team spirit and excellent communication skills.



3. Functions:

Development of various activities for the BioAqua Matosinhos project / Ponds with Life Campaign, namely the construction, colonization, inventory, management and recovery of ponds, educational activities, social media management and other dissemination and communication activities developed by the project.

4. Applicable legislation and regulations:

Law nº. 40/2004, 18th August (Research Fellowship and Studentship Regulation) in its current version; Regulations for Studentships and Fellowships of the Fundação para a Ciência e a Tecnologia, I.P. and CIIMAR Grants Regulation approved by FCT.

- 5. **Workplace:** The work will be developed at CIIMAR, located at the Cruise Terminal of the Port of Leixões, Av. General Norton de Matos, s / n, 4450-208 Matosinhos;
- 6. **Duration of the grant:** Duration of 12 months, starting January 1s^t, eventually renewable according to legal terms.

7. Monthly salary

The monthly maintenance allowance is €1,309.64, in accordance with the table of monthly maintenance allowances for grants awarded directly by FCT, I.P. within the country https://www.fct.pt/wp-content/uploads/2025/02/Tabela_valores_SMM_2025.pdf. Payment will be made by bank transfer. In addition to this grant, the beneficiary will be covered by personal accident insurance.

8. Selection methods:

The selection will be made according to:

- Curriculum assessment 40%
- Experience in the area 50%
- Other relevant elements 10%

The evaluation process includes the possibility of a professional selection interview for candidates with an assessment higher than 80% in the first phase. The interview will have a weight of 50% of the total of the final evaluation. The interview is optional if there is only one candidate in the previous conditions.

10. Form of advertising / notification of results: the final results of the evaluation will be published, through an ordered list, the final score obtained, on the CIIMAR website and simultaneously by e-mail; if the decision is unfavourable, the candidates have 10 working days to comment, in the context of a prior hearing, under the terms of the Administrative Procedure;

11. Application deadline and form of submission of applications:

The competition is open from **5/12/2025 until 19/12/2025**.
